

## ARTICLES OF INCORPORATION OF

#### ALTEX TRADING CORP.

THE UNDERSIGNED incorporator does hereby make subscribe, acknowledge and file with the Department of State these Articles of Incorporation for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

### ARTICLE I - NAME

The name of this Corporation shall be

#### ARTICLE II - GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

#### ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock authorized to be issued by this Corporation par \$1.00 Value shall be:

Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All stock when issued shall be fully paid for and shall be nonassessable.

#### ARTICLE V - TERM OF CORPORATE EXISTENCE
