**ARTICLE 1, CORPORATE NAME**

The general nature of the business to be transacted by this Corporation is to engage in any business permitted under the Law of the State of Florida

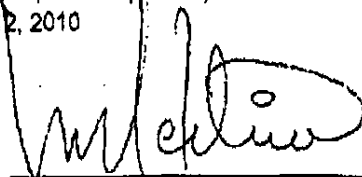
## **ARTICLE IX AMENDMENT**

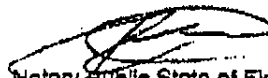

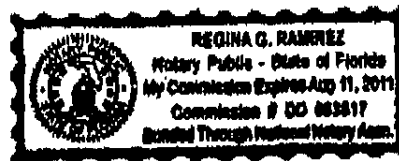

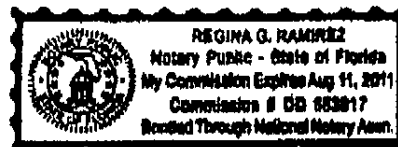
