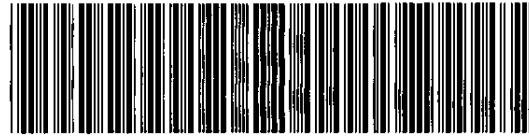

The undersigned, desiring to form a professional corporation in the State of Florida pursuant to Florida Statute, Chapter 607 and Chapter 621, hereby certifies:

**ARTICLE I - NAME**

The name of the Corporation is AARON YOU MASTNY, P.A.

**ARTICLE II - EXISTENCE**

The existence of the Corporation commences upon the filing of these Articles with the Florida Department of State and shall continue in existence until terminated by operation of Florida law, or (i) in accordance with the Corporation's Bylaws, or (ii) upon unanimous written consent of the Corporation's shareholders.

**ARTICLE III - ADDRESS**

**ARTICLE VII – REGISTERED AGENT**


