ARTICLES OF INCORPORATION
OF
T-WIRE CORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is T-WIRE CORPORATION. The principal place of business is 1110 N. Palafox St., Pensacola, Florida 32503.

ARTICLE II
DURATION

The duration of this corporation is perpetual.

ARTICLE III
PURPOSE

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida Business Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue 500,000 shares of zero dollars per share par value voting common stock, which shall be known as and referred to as "Series A Shares," and

500,000 shares of zero dollars per share par value voting preferred stock which shall be known as and referred to as "Series B Shares." The Series B Shares shall have such preferences and the holders thereof shall have such rights as are specified in a shareholders agreement executed by the holders of all Series A Shares and Series B Shares issued by the Corporation.

ARTICLE V
REGISTERED OFFICE AND AGENT

The street address of the initial registered office, and the mailing address of the Corporation in this State is 24 West Chase Street, Pensacola, Florida 32502, and the name of its initial registered agent at such address is Daniel R. Lozier.

ARTICLE VI
BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of at least one (1) member. The size of the board may be increased or decreased from time to time as prescribed in the bylaws or by applicable law, but never shall the board consist of less than one (1) member.

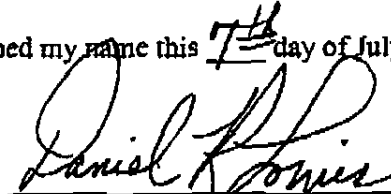
