## ARTICLES OF INCORPORATION

OF

### ARISTOCRAT INVESTMENTS INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### ARTICLE I

The name of the Corporation ("Corporation") is ARISTOCRAT INVESTMENTS INC.

#### ARTICLE II

The existence of the Corporation shall begin on the filing of these Articles of Incorporation with the Florida Department of State, Division of Corporations.

#### ARTICLE III

The street address of the principal office of the Corporation is 100 Besserer Street, Suite 1909, Ottawa, Ontario, Canada, K1N 9M9.

#### ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

#### ARTICLE V

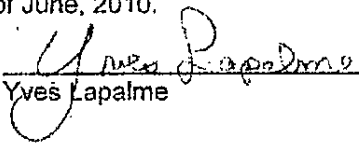
