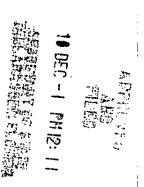

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF AIR CONTROL HEATING AND AIR CONDITIONING, INC.

These Articles of Amendment are filed pursuant to Florida Statutes Section 607.1006, to reflect an amendment to the Articles of Incorporation of Air Control Heating and Air Conditioning, Inc., and in connection therewith, the undersigned officer, acting upon authority of the Board of Directors of Air Control Heating and Air Conditioning, Inc., and upon authority of the holders of all of the shares entitled to vote on this Amendment, hereby sets forth as follows:

- 1. The name of this Corporation is Air Control Heating and Air Conditioning, Inc.
- 2. The Articles of Incorporation of Air Control Heating and Air Conditioning, Inc. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article I:
