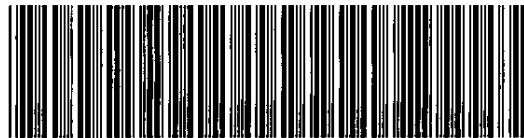



We hereby file to dissolve the for profit corporation to release the name and make it available for use with the new entity.



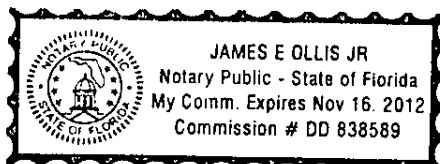


