**ARTICLES OF INCORPORATION
OF

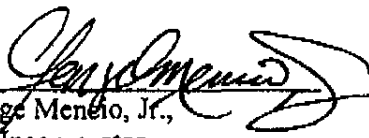
ARTICLE IX. BYLAWS

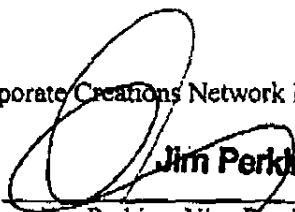
