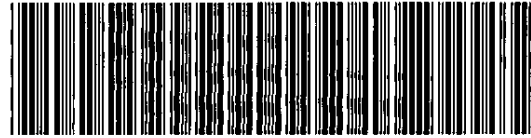



ARTICLES OF INCORPORATION

OF

JENNIFER BILES, INC.

ARTICLE I

The name of this corporation is: JENNIFER BILES, INC.




