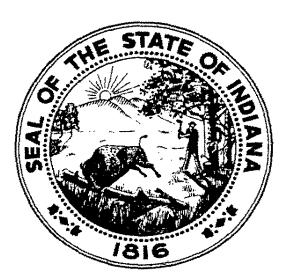

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF BSA DESIGN, INC

BSA Design, Inc.
