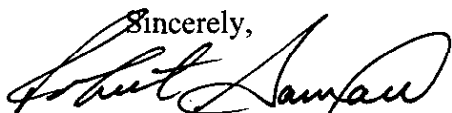
Re; Profit Corporation Annual Report 2000
