**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a professional services corporation in accordance with Florida Statutes Chapters 621 and 607, do hereby adopt the following Articles of Incorporation:

**ARTICLE 1.0 NAME AND ADDRESS**

The name of the Professional Corporation is 4A Autopsy Services, P.A. The location of the principal place of business is 2587 Windwood Lane, Orange Park, Florida, 32073 and the mailing address is P.O. Box 1901, Orange Park, Florida, 32067-1901.

**ARTICLE 2.0 DURATION**

The duration of the Corporation is perpetual.

**ARTICLE 3.0 PURPOSE**

The purpose for which the Corporation is organized is to provide professional medical autopsy and related services by individuals duly licensed under the laws of the State of Florida to perform such services.

**ARTICLE 4.0 SHARES**


