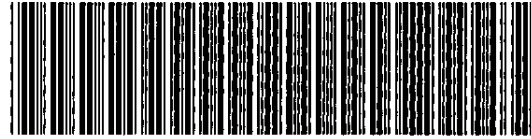

Article I: Name




