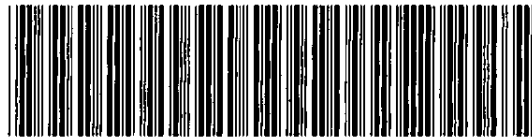

Name

The name of this corporation is OKEANIS TRADE, INC.

Principal Office Address


