The undersigned Incorporator hereby submits the following Articles of Incorporation of **Stephen J. Mangan, D.M.D., P.A.** for the purpose of forming a professional service corporation pursuant to Chapter 621 of the Florida Statutes.

ARTICLE I.

Name

The name of the Corporation is "Stephen J. Mangan, D.M.D., P.A." (hereinafter called the "Corporation").

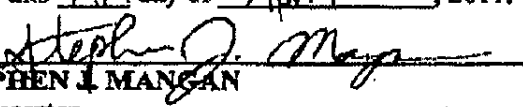

These Articles of Incorporation may be altered, amended or repealed by the Board of Directors or shareholders of the Corporation in accordance with the applicable provisions of Florida law.

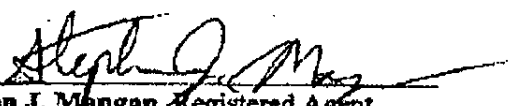
