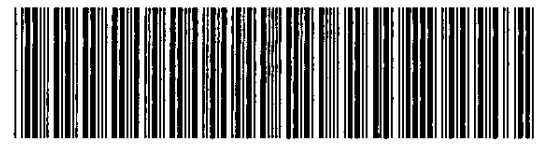



ARTICLES OF INCORPORATION

OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I. The name of the corporation shall be *VOCAL PRO, INC.*. The principal place of business shall be 1859 Shady Hill Terrace, Winter Park, Florida 32792.

II. The duration of this corporation is perpetual unless dissolved according to law.

III. The purposes for which this corporation is organized are:

1. To educate the art of communication to children.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.

3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

IV. The aggregate number of shares which the corporation is authorized to issue is five hundred (500). Such shares shall be of a single class, and shall have a par value of ten dollars (\$10.00) per share.

V. The number constituting the initial Board of Directors is two (2). The method for electing Directors shall be as stated in the Bylaws of the corporation. VII. The names and addresses of the incorporators are the same as the initial directors, listed above.

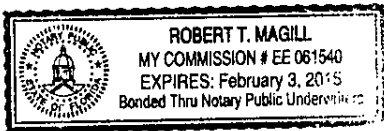
