## AFFIDAVIT regarding

## THIRD PARTY'S INTENT to DEFRAUD

BEFORE ME, the undersigned authority, duly authorized to administer oaths and take acknowledgements, appeared MAYLINE TORRES, individually and as President of TRUCKING SOLUTIONS, INC., a Florida Corporation, who after being duly sworn, deposes and says the following:

- 1. On or about March 24, 2025, Torres discovered that an Annual Report for the Company was filed with the Florida Department of State. Upon reviewing the filing, it was evident that it had been submitted by an individual named Albert Genao, who is not affiliated with the Company in any capacity. No authorization was granted by Torres or any other legitimate representative of the Company for Mr. Genao to act on behalf of Trucking Solutions Inc. in any matter, including the filing of the Annual Report.
- 2. Albert Genao is not an employee, officer, director, or any other authorized representative of Trucking Solutions Inc. Torres has no knowledge of Mr. Genao having any authority or relationship with the Company, and at no time was he authorized to file or submit any official documents, including the Annual Report, on behalf of the Company.
- 3. Upon discovering the fraudulent filing, Torres promptly contacted the Florida Department of State to report the issue and seek corrective measures. She is fully cooperating with the appropriate authorities to ensure that the fraudulent filing is corrected, and that the Company's records accurately reflect the legitimate representatives and officers of the Company.
- 4. Torres affirms that the filing of the Annual Report by Albert Genao was fraudulent and unauthorized. Torres respectfully requests that the Florida Department of State take the necessary actions to investigate and rectify this matter, ensuring that the Company's official records are corrected to reflect the true and accurate representatives of Trucking Solutions Inc.
- 5. Attached hereto as Exhibit A is a true and correct copy of the official document identifying, Mayline Torres, as the authorized representative and President of

Trucking Solutions Inc. This document clearly demonstrates her role as the sole authorized individual to act on behalf of the Company, including the filing of the Annual Report with the Florida Department of State.

Under penalties of perjury, I declare that I have read the foregoing Affidavit and that the facts stated in it are true.
