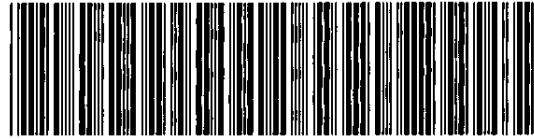

Nature of Business**

This Corporation is being formed for the following purposes:

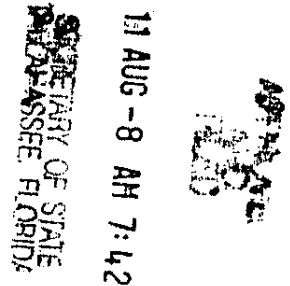
