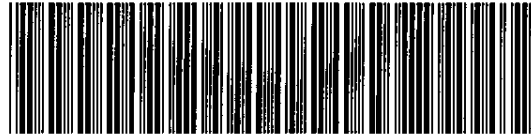




## ARTICLE IX - POWER OF CORPORATION
