**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **AMERICAN SCREEN CONTRACTORS, INC.**, a Florida corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation is American Screen Contractors, Inc.
2. The original Articles of Incorporation of the Corporation (the "Articles") were filed on December 8, 2011, and assigned Document No. P11000104668.
3. The following amendment to the Articles was adopted by the directors and shareholders of the Corporation by written consent dated June 14, 2023, in accordance with the provisions of Sections 607.0821 and 607.0704 of the Florida Statutes. Such written consent of the shareholders represents a sufficient number of votes cast for such amendment necessary for the approval thereof.
4. Article I of the Articles is hereby amended and restated in its entirety and replaced with the following:
