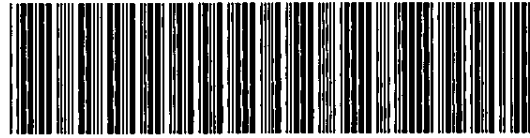

OF

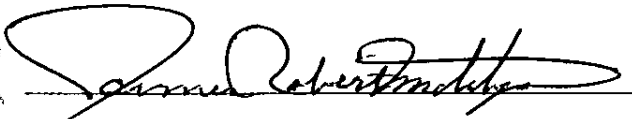
