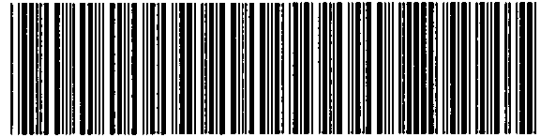

Article I
Name

The name of this corporation is MBS SWISS MANAGEMENT, CORP.

Article II
Principal Office Address

Nature of Business

This Corporation is being formed for the following purposes:




