**ARTICLE I - NAME**

The name of the corporation shall be Young Marketing & Advertising, Inc. (hereinafter, the "Corporation" or the "Company").

**ARTICLE II - PURPOSE**

The name and address of the incorporator is Ronald L. Stephenson, 770 Second Avenue South, St. Petersburg, Florida 33701.

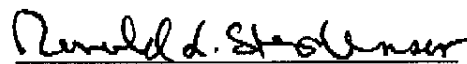
