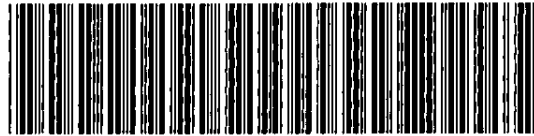

AMENDMENT

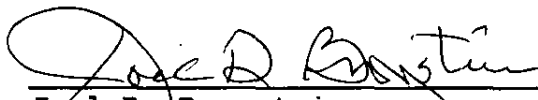
