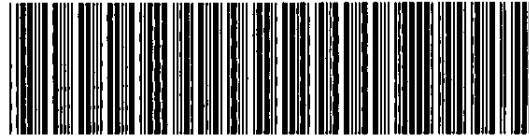

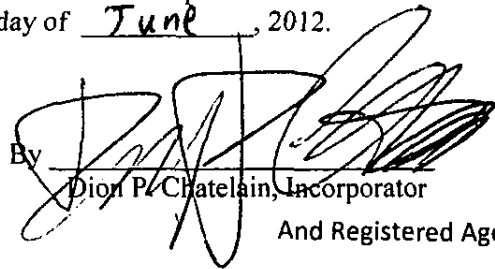
ARTICLE IX INDEMNIFICATION
