**ARTICLES OF INCORPORATION
OF
HORISO, INC.,
a Florida corporation**

The undersigned, acting as Incorporator of HORISO, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I

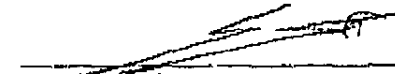
**ARTICLE VI

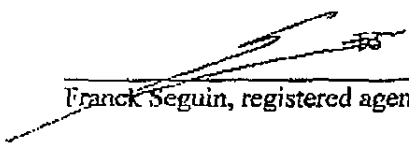
