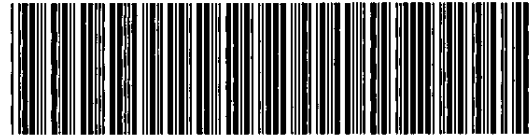

ARTICLES OF INCORPORATION

OF

A2B SPORTS INJURY REHAB, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be A2B Sports Injury Rehab, Inc., (the "Corporation"). The address of the principal office of the Corporation shall be 8939 North Dale Mabry Highway, Tampa, Hillsborough County, Florida 33614, and the mailing address shall be the same.

ARTICLE II. CAPITAL STOCK

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one (1), the exact number to be determined from time to time in accordance with the Bylaws.




