ARTICLES OF INCORPORATION OF

ARTICLE I. NAME

The name of the corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is five million (5,000,000) shares of common stock having a par value of \$0.01 per share. Effective as of June 5, 2014, each of the one hundred (100) shares of the corporation's common stock then issued and outstanding shall be automatically converted into 24,890.75 fully paid and non-assessable shares of common stock of the corporation (the "Stock Split"). The Stock Split shall not affect the total authorized number of shares of the corporation's common stock, and shall affect only the shares of the corporation's common stock issued and outstanding as of June 5, 2014. This provision shall not change the stated capital or paid-in surplus in respect of the common stock issued and outstanding as of June 5, 2014, if any.
