# ARTICLES OF INCORPORATION SECRETARY OF STATE OF IMPLANASSEE, FLORED DESIGNERS GROUP INC

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for profit.
