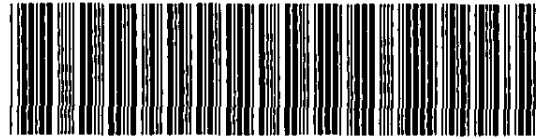

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE :

BALBO CONSULENTE INVESTIMENTI COMPANY

ARTICLE II

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 5,000 shares of common stock, ~~and which common stock shall be of no par value~~ (shall have a par value of \$ 1.00 per share).

All stock is to be issued as fully paid and exempt from assessment.


