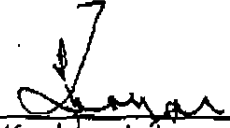
ARTICLE X

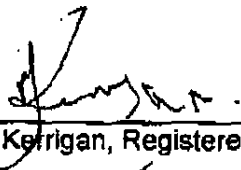
