## ARTICLE I – NAME

The name of the Corporation is ABOVE & BEYOND ERRAND SERVICE, INC.,  
(hereinafter, "Corporation").

## ARTICLE II – PRINCIPAL OFFICE

## ARTICLE III – PURPOSE OF CORPORATION
