ARTICLE I: The name of the corporation is Teleset US, Inc.

ARTICLE II: The principal office is located at 10202 W. Washington Boulevard, Culver City, Florida 90232, with a mailing address of 10202 W. Washington Boulevard, SPP 1132, Culver City, Florida 90232.

ARTICLE III: The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Statutes, other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the State of Florida.


