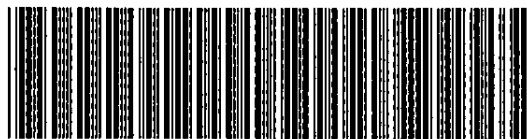

ARTICLES OF INCORPORATION
OF

ARTICLE I -- NAME

The name of this professional corporation, formed under the provisions of Section 621, Florida Statutes, is STACEY B. JONES, PH.D., P.A.

ARTICLE II -- PRINCIPAL OFFICE
