**ARTICLE I - NAME**

The name of the corporation shall be: **INVESTMENT MANAGERS LIMITED USA CORP.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. Corporate existence shall commence at the time of filing of the Articles by the Department of State, State of Florida.






