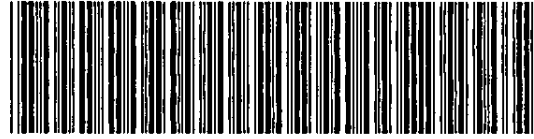

The Seventh Article of the Articles of Incorporation of the above referenced Corporation is hereby amended to read:

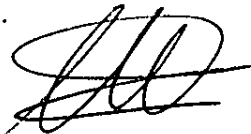
ARTICLE VII: The correct name of the President of the board of directors shall be:

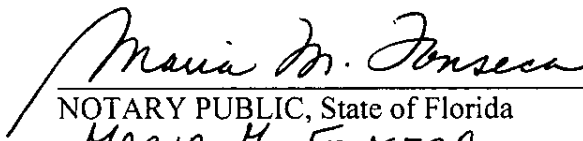
