The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of **GLENN A BRACKETT**, **PA** does hereby set forth and declare:

CHARTER

ARTICLE I

The name of the corporation shall be **GLENN A BRACKETT**, **PA**, Community of Bonita Springs, County of Lee, State of Florida.

ARTICLE II

The corporation will be engage in Real Estate Sales activity, however, may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The amount of indebtedness or liability to which the corporation at any time may subject itself shall be unlimited.

ARTICLE XI

ARTICLE XII

Each shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
