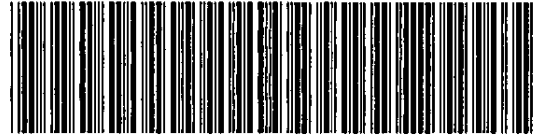



The undersigned, acting as incorporators for this not for profit corporation pursuant to Chapter 617 of the Florida Statutes, hereby form a Not for Profit Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **SMITH COLLEGE CLUB OF CENTRAL FLORIDA, INC.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 29 day of August, 2013, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be a social organization that connects former students of Smith College with other Smith College students of the past, present, and future and establishes a scholarship fund in addition to other services and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV
CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is One Thousand (1,000) shares of common stock, having a par value of One Dollar (\$1.00) per share.

ARTICLE V
REGISTERED OFFICE, REGISTERED AGENT, AND PRINCIPAL OFFICE


