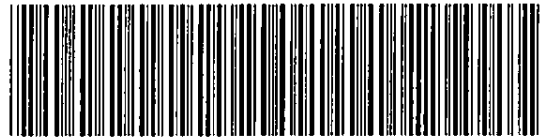

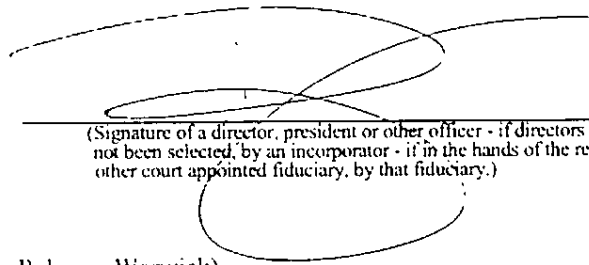

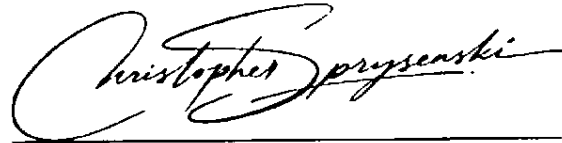
THIS CAUSE came before the Court on the Petition for Change of Name (Adult) under Fla. Stat. § 68.07, and it appearing to the Court that:

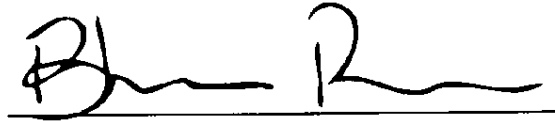
