

Pursuant to the Official Code of Georgia Annotated

("O.C.G.A.") § 14-2-1106 of the Georgia Business Corporation

Code, SAUNDERS & ROBERTS, ARCHITECTS, INC., a Georgia

corporation, hereby submits the following Articles of Amendment
to its Articles of Incorporation.

1.

The name of the professional corporation is SAUNDERS & ROBERTS, ARCHITECTS, INC., and the charter number of the corporation is #86028193.

II.

Effective the date hereof, the Articles of Incorporation of Saunders & Roberts, Architects, Inc., which were previously amended on December 16, 1992, are hereby amended by deleting therefrom Article I and by substituting a new Article I to read as follows:

The name of the corporation shall be "SAUNDERS, ROBERTS & JOHNSON, ARCHITECTS, INC."

III.

The Articles of Incorporation are further amended by deleting the words "Saunders & Roberts, Architects, Inc." wherever same appears throughout the Articles of Incorporation, as amended, and by inserting in lieu the words "SAUNDERS, ROBERTS & JOHNSON, ARCHITECTS, INC."

ARTICLE XVIII

This amendment was duly approved, in accordance with the provision of O.C.G.A. § 14-2-1003 of the Georgia Business Corporation Code, by the affirmative vote of all of the shareholders of the Corporation present at a Special Meeting of Shareholders thereof held at the offices of Watson, Spence, Lowe & Chambless on the 8th day of January, 1996, at which all shareholders were present in person and qualified to vote.
