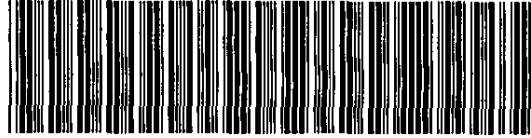

Article 1 Name:

The name of the corporation shall be ABT Trust, Inc. and the commencement date of the corporation shall be October 8, 2013;




