### **ARTICLE VIII: INITIAL BOARD OF DIRECTORS**

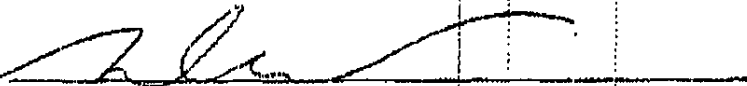
