NAME

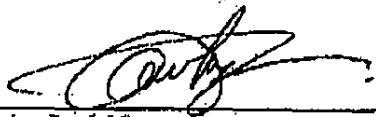
ARTICLE X

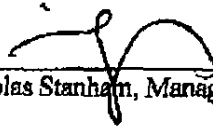
