ARTICLES OF INCORPORATION
OF

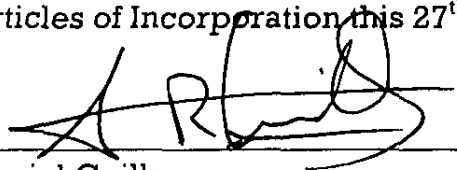
Article X

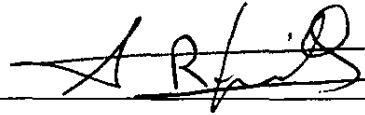
