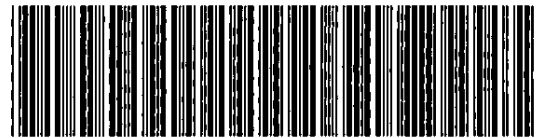

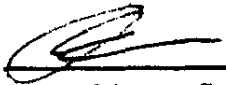
**SPECIAL AND REVOCABLE
