# ARTICLES OF INCORPORATION

# ARTICLE I - NAME

The name of the corporation is M & M Refrigeration of Central Florida, Inc., at 2026 Michels Drive NE, Palm Bay, FL 32905 (Principal Office of Registered Agent).

# **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

# ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

#### ARTICLE IV - CAPITAL STOCK
