**ARTICLE I - NAME**

The name of the social purpose corporation is Tech Care for Kids, Inc.

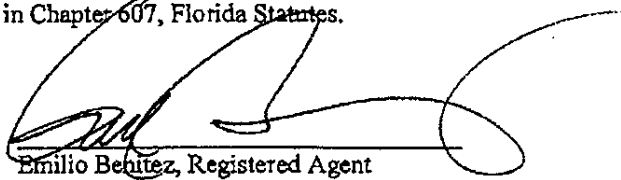
