In compliance with Chapter 607 Florida Statutes, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I - NAME

The name of the social purpose corporation is Tech Care for Kids, Inc.


