It was agreed by the Board of Directors to amend the Articles of Incorporation to establish two (2) new Series of Preferred Classes of stock. Series "P" with an authorized amount of 7,500,000 shares at \$0.001 par value; and Series "M" with an authorized amount of 10,000,000 shares at \$0.001 par value. Both classes shall be non-dilutable stock with voting rights - votes with the Common at 1 vote per share. Conversion rights - converts to Common stock at a ratio of 1 share preferred to 1:25 shares of Common. All newly issued Stock are subject to a lock-up/leak-out agreement. Liquidation limited to 25% in 6 months and one day and subsequently 25% per year.

The Amended Articles of Incorporation will become effective upon filing with the Florida Secretary of State.
