TO THE

Pursuant to the provisions of Section 607.1006, Florida Statutes, PELICAN WIRE COMPANY 2014, a Florida corporation (the "Corporation"), hereby adopts the following amendment to the Corporation's Articles of Incorporation:

1. The name of the Corporation is Pelican Wire Company 2014.
2. Article I of the Corporation's Articles of Incorporation is hereby amended by deleting it in its entirety and inserting in lieu thereof the following:

CORPORATE NAME**


"The name of the corporation shall be PELICAN WIRE COMPANY"
